PHONE BID FORM

1. Registration: To register to bid by phone, Dallas Fine Art Auction (DFAA) requires a current driver's license and a valid credit card on file for authorization. All successful bids will be charged a 19.5% buyer's premium for the portion up to and including \$200,000 and 12% on any portion over \$200,000 and any applicable Texas sales tax in addition to the hammer price. By submitting a phone bid(s), you agree that you have read, understand, and are bound by the Terms & Conditions of Sale of DFAA. The Terms & Conditions are available online at www.dallasfineartauction.com or at our offices.

2. PAYMENT - Domestic Clients: We accept bank wire transfer, cash, personal or company check with proper ID, cashier's check, money order, Visa, MasterCard, or American Express. Your credit card will be charged the day after the auction. If other payment arrangements have been made and good funds have not been received by the 5th business day after the auction, your credit card will be charged. If paying by check, DFAA reserves the right to hold all purchases until the check has cleared to the satisfaction of DFAA and its bank. International Clients: We accept bank wire transfers, Visa, MasterCard, or American Express. For items purchased via phone or absentee bidding, your credit card will be charged the day after the auction. If other payment arrangements have been made and good funds have not been received by the 5th business day after the auction, your credit card will be charged. Please note: There is a maximum of \$25,000 that may be charged to credit cards, per client invoice.

3. Shipping: It is your responsibility to arrange for and pay for shipping. All purchases should be removed from our premise by 5:00 pm on the 5th business day following the auction. Items not removed by the specified time will be subject to storage charges of \$10 per item per day.

4. DFAA offers phone bidding as a convenience to clients who are unable to attend the auction. There is limited capacity to handle phone bids so please make arrangements as soon as possible. DFAA will not be held responsible for any error; failure to execute bids, or inability to connect by phone. A representative from DFAA will call you on the number(s) you have indicated as far in advance as possible on the lot(s) you are bidding on.

5. Phone bidding is allowed only on lots with a low estimate of \$1000 or greater.
